unto Maynard E. Stych, his heirs and assigns forever:

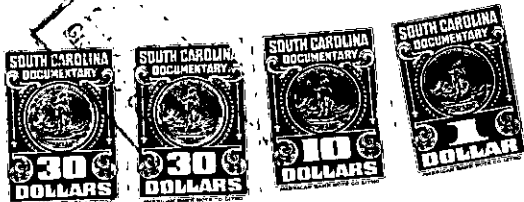
