The Grantor(s) herein by these presents warrants that there are no liens, mortgages, or other encumbrances to a clear title to these lands, except as follows(1) Mortgage to Carolina Federal Savings & Loan Association recorded in REM Volume 926 at Page 404 (2) Mtg. to Tina Garrett Davis recorded October 30, 1964, which is recorded in the office of the R.M.C. of the above said State and County in Mortgage Book 977 at Page . and that he (she) is legally qualified and entitled to grant a right of way with reto the lands described herein. spect The expression or designation "Grantor" wherever used herein shall be understood to include the Mortgagee, if any there be. 2. The right of way is to and does convey to the grantee, its successors and assigns the followings: The right and privilege of entering the aforesaid strip of land, and to construct, maintain and operate within the limits of same, pipe lines, manholes, and any other adjuncts deemed by the grantee to be necessary for the purpose of conveying sanitary sewage and industrial wastes, and to make such relocations, changes, renewals, substitutions, replacements and additions of or to the same from time to time as said grantee may deem de-
