unto DEMPSEY RAYMOND HUDSON AND MYRNA B. HUDSON, their heirs and assigns;

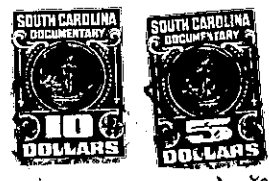
