KNOW ALL MEN BY THESE PRESENTS, that I, Ward S. Stone, of Greenville County,

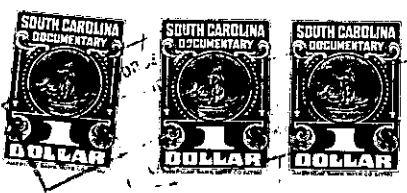
in consideration of One Thousand, Five Hundred and No/100 (\$1,500.00)-----Dollars,

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot No. 43 of a subdivision of the property of Lanco, Inc. as shown on plat prepared by R. K. Campbell and Webb Surveying & Mapping Co., October, 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Page 199, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Dunlap Drive, joint front corner of Lots 42 and 43 and running thence along the joint line of said lots, S. 14-29 W. 124.7 feet to an iron pin on line of Lot 41; thence along the line of that lot, N. 66-25 W. 45 feet to an iron pin at the joint rear corner of Lots 37 and 36; thence along the rear line of Lot 36, N. 35-36 W. 66.7 feet to an iron pin at the rear corner of Lot 44; thence along the line of that lot, N. 51-14 E. 119.1 feet to an iron pin on the western side of Dunlap Drive; thence along the western side of Dunlap Drive, S. 50-45 E. 28.5 feet to an iron pin; thence continuing along the western side of Dunlap Drive, S. 55-04 E. 32 feet to the beginning corner.
