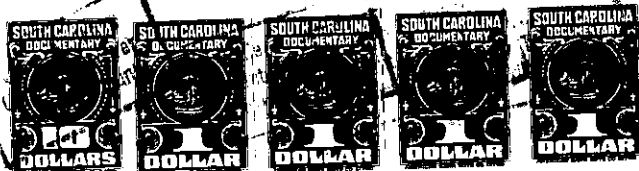
KNOW ALL MEN BY THESE PRESENTS, that Danny L. Hastings and Linda K. Hastings -----
