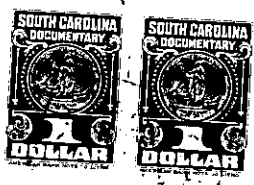
KNOW ALL MEN BY THESE PRESENTS, that WE, Andrew H. Norman and Doris C. Norman,
