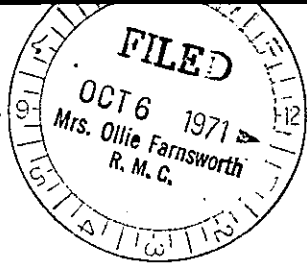

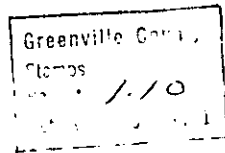
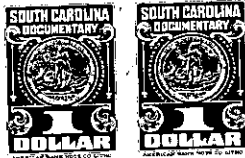

ALL that piece, parcel or tract of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 25 as shown on plat of Block 5 of Midway Acres according to a survey made by Webb Surveying & Mapping Company, March, 1967, of the Property of S. C. Beattie Estate in Cleveland Township and having according to said plat the following courses and distances, to wit:
