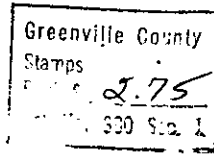

All of that lot of land in the City of Greenville, in Greenville Township, Greenville County, State of South Carolina, on the West side of Rutherford Street, and having the following metes and bounds:

BEGINNING at a pin on Rutherford Street, corner of property now or formerly of C. A.
