

KNOW ALL MEN BY THESE PRESENTS, that COURTNEY P. HOLLAND

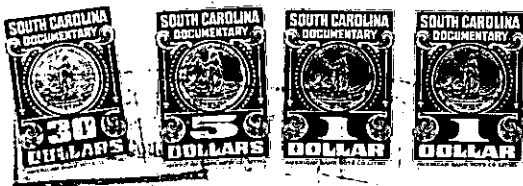
in consideration of Eighteen Thousand Five Hundred and No/100-----Dollars,
