ALL that lot of land with the buildings and improvements thereon situate on the west side of Buckingham Road in the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 234 on plat of Section B of Gower Estates recorded in the RMC Office for Greenville County, South Carolina, in Plat Book XX, Pages 36 and 37; having according to said plat, the following metes and bounds, to-wit:
