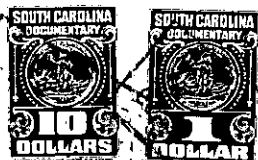
in consideration of FIVE THOUSAND TWO HUNDRED FIFTY AND NO/100---(\$5,250.00)----- Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto HAROLD W. LUSK, and Betty J. Lusk, their Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, about 7 miles Southwest of the City of Greenville, and being known and designated as Lot Number 36 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book 000 at Page 193, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northwestern side of Driftwood Drive at the joint front corner of Lots 35 and 36 and running thence with the Northwestern side of Driftwood Drive S 34-54 W 80 feet to a point; thence continuing with the Northwestern side of Driftwood Drive S 23-42 W 80 feet to a point; thence still continuing with the Northwestern side of Driftwood Drive S 12-30 W 80 feet to a point at the joint front corner of Lots 36 and 37; thence N 85-06 W 298.3 feet to a point at the joint rear corner of Lots 36 and 37; thence N 14-59 E 88 feet to a point; thence N 26-03 E 331.5 feet to a point at the joint rear corner of Lots 35 and 36; thence S 49-30 E 294.8 feet to a point on the Northwestern side of Driftwood Drive at the point of BEGINNING.
