KNOW ALL MEN BY THESE PRESENTS, that I, Jimmy Lee Pruitt

in consideration of One Dollar (\$1.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto JOHN BOOTH, HIS HEIRS AND ASSIGNS FOREVER:

All my right, title and interest in that property described as follows:

ALL that certain piece, parcel or lot of land, situate, lying and being in the State and County aforesaid, Oneal Township, near Millford Baptist Church, lying on the northern side of an old road, being bounded on the West by lands of W. Dennis Smith, on the north by lands of the Commission of Public Works of Greer, S.C. (Stone Tract) and on the South by other lands of myself, and being a part of the same land conveyed to me by deed from J. H. Grant, dated January 9, 1965, recorded in Deed Book 767 at page 100 in the R.M.C. Office for Greenville County, and having the following courses and distances, to wit:

BEGINNING on an old iron pin on the line of the Commission of Public Works tract, and runs thence with the line of the said tract, S. 47-35 E. 440 feet to an old iron pin; thence S. 49-20 W. 66 feet to an iron pin in the said old road; thence with the said old road, N. 59-10 W. 506.5 feet to a stake in the said old road and on my original northern line; thence with the said line, N. 63-45 E. 10 feet to an iron pin, then continuing with the same course and line for a total distance of 179 feet to the beginning corner, containing One and Two Tenths (1.2) acres, more or less.

This deed is given to correct a deed recorded in deed Book 767 at page 100 in the R.M.C. Office for Greenville County, wherein the Grantors name appeared as a Grantee, but was struck out. It was the intention of the Grantor herein, not to receive any interest in the above described property.
