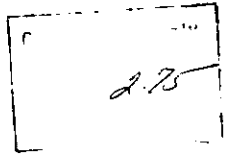

All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, at the northwesterly intersection of Belvue Road and Dahlgreen Lane, being shown and designated as Lot No. 3, on plat of Rolling Acres, recorded in the RMC Office for Greenville County, S. C., in Plat Book "GGG", at Page 200, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northerly side of Belvue Road, joint front corner of Lots Nos. 2 and 3, and running thence with the joint lines of said lots, N. 40-07 E. 150 feet to an iron pin in line of Lot No. 17; thence with line of Lot No. 17, S. 49-53 E. 125 feet to an iron pin on the westerly side of Dahlgreen Lane; thence with said Lane, S. 13-41 W. 11.2 feet to a point; thence continuing with said Lane, S. 40-07 W. 115 feet to a point; thence with the intersection of Dahlgreen Lane and Belvue Road, on a curve, the chord of which is S. 87-07 W., 35.3 feet to an iron pin on the northerly side of Belvue Road; thence with said Road, N. 49-53 W. 105 feet to the point of BEGINNING.

The within conveyance is subject to restrictions of record, and is also subject to utility easements and rights-of-way of record or on the ground, along with tap fees, set back lines, and zoning regulations.
