unto David S. McGahee, Jr. and Jane R. McGahee, their heirs and assigns forever:

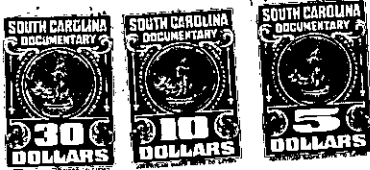
