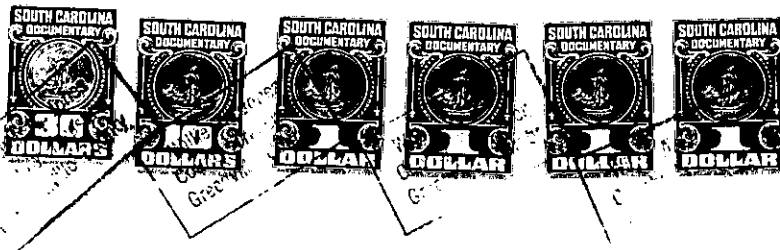
KNOW ALL MEN BY THESE PRESENTS, that Jimmie Eugene Fulp -----
