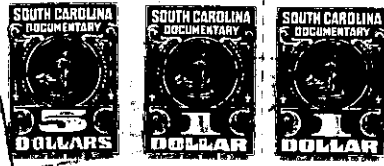
C. R. LAEMMEL, HIS HEIRS AND ASSIGNS, FOREVER:

All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, at the intersection of Fillery Drive and Oakway Circle, being shown and designated as Lot No. 17, on plat of Property of Oakway, recorded in the RMC Office for Greenville County, S. C., in Plat Book "JJJ", at Page 107, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northwesterly side of Fillery Drive, joint front corner of Lots Nos. 17 and 18, and running thence S. 13-30 W. 159 feet to a point; thence with the intersection of said Drive and Oakway Circle, S. 46-0 W. 42 feet to an iron pin on the northerly side of Oakway Circle; thence with the northerly side of said Circle, S. 78-48 W. 150 feet to the joint front corner of Lots Nos. 16 and 17; thence with the joint lines of said lots, N. 25-35 W. 238.7 feet to an iron pin; thence N. 37-45 E. 40 feet to an iron pin, joint rear corner of Lots Nos. 17 and 18; thence with the joint lines of said lots, S. 70-52 E. 351.5 feet to the point of BEGINNING.

The within conveyance is subject to restrictions of record, and is also subject to utility easements and rights-of-way of record or on the ground, along with tap fees, set back lines, and zoning regulations, and is particularly subject to drainage easements along the northerly and westerly boundaries of the subject property, as shown on the recorded plat.
