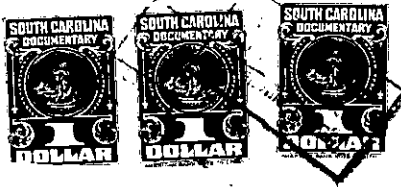
L. D. Snelson, his heirs and assigns forever:
