An undivided two-thirds (2/3) interest in and to:

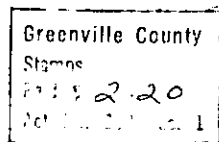
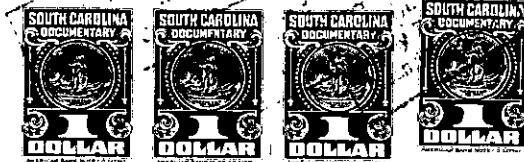
