GREENVILLE COUNTY CORRECTION DEED

KNOW ALL MEN BY THESE PRESENTS, that we, E. P. Alford and Clayton W. Alford

in consideration of ----- FIVE THOUSAND AND NO/100 -----

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

JOHN H. CAULEY, his heirs and assigns forever,

ALL that piece, parcel or lot of land with improvements thereon situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Northeast side of Skyland Drive (formerly known as Bates Avenue) and designated as LOT No. 36 on plat of Skyland Drive made by Dalton & Neves, March 1941 and recorded in the RMC Office for Greenville County in Plat Book L, at page 41 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northeast side of Skyland Drive at joint front corner of Lots 35 and 36 and running thence along line of Lot 35, North 49-16 East 143.3 feet to an iron pin; running thence North 47-0 West 40 feet to an iron pin; thence along the line of Lot No. 37, South 54-17 West 128.8 feet to an iron pin on the Northeast side of Skyland Drive; thence along the Northeast side of Skyland Drive, South 28-56 East 52 feet to the beginning corner.

This being the same property conveyed to the Grantors herein by deed of James William Cox as recorded in Deed Book 639, at page 279, RMC Office for Greenville County.
