A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of

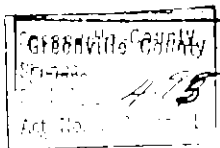

ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville on Old Mill Road, being shown as Lot No. 78 on plat of Edwards Forest Heights recorded in Plat Book 000 at page 89, and being more fully described as follows:

BEGINNING at the joint front corner of Lots Nos. 77 and 78 and running thence South 54-38 West 225 feet to Edwards Mill Road; thence along Edwards Mill Road, South 50-11 East 113.5 feet to the joint rear corner of Lots Nos. 78 and 79; thence with the joint line of said lots North 54-38 East 195 feet to Old Mill Road; thence along said Road, North 35-22 West 110 feet to the beginning corner.
