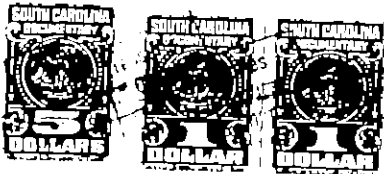
in consideration of THREE THOUSAND TWO-HUNDRED (\$3,200.00)-----Dollars
