(The receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mary Lou Thompson Campbell, her heirs and assigns forever:

All of our right, title and interest in and to:

All that certain piece, parcel or lot of land in ~~the~~ Dunklin Township, Greenville County, State of South Carolina, adjoining lands of Dr. B. T. West, R. B. Arnold, Estate of Robert Scott and others containing Sixty-three and three quarters of an acre, more or less, and bounding the following lines, metes and bounds, to wit:

BEGINNING on a rock, thence S 61 - E 22.00 to a rock 3x, thence N 41 - W 22.75 to a hickory 3x; thence N 18 - W 10 to a rock 3x; thence S 72 - W 20 to a rock 3x; thence S 30^E 42.00 to the beginning corner.
