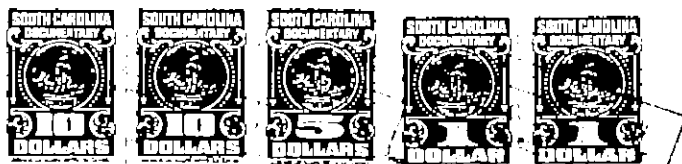
KNOW ALL MEN BY THESE PRESENTS, that Bobby Dove and Patricia B. Dove -----
