KNOW ALL MEN BY THESE PRESENTS, That Humble Oil & Refining Company

in consideration of the sum of one dollar (\$1.00) to it in hand paid by DUKE POWER COMPANY, the receipt whereof is hereby acknowledged, does hereby grant unto said DUKE POWER COMPANY, its successors and assigns, the right, privilege and easement to go in and upon that certain tract or lot of land situated in said County and State, bounded by lands of: 200' ± on S. C. Hwy. #291 to the east and 250' ± on S. C. Hwy. #291 Bypass to the north, being a square lot more or less,

and to construct, maintain and operate in, upon and through said premises, in a proper manner with poles, wires, guys, conduits, cables, transformers, and other necessary apparatus and appliances, overhead or underground lines for transmitting and distributing power by electricity, and for telephone purposes, together with the right at all times to enter said premises for the purpose of inspecting said lines and making necessary repairs and alterations thereon and additions thereto; together with the right at all times to cut away, or by other means to keep clear of said lines, all trees, brush, structures and other obstructions that may, in any way, endanger the proper maintenance and operation of the same; also including the right to relocate said lines over said premises to conform to any future highway or street relocation, widening or improvement. Duke Power Company's electrical service line to enter Humble Oil & Refining Company's property at the point and to be located as shown on the attached layout marked Exhibit "A", dated 2/3/72, and initialed by C. W. Wallace. This line is to only serve Humble and is not to be used to serve any other property other than Humble's.

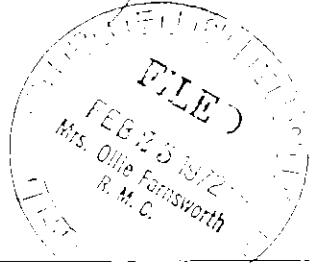
