KNOW ALL MEN BY THESE PRESENTS, that I, Dartha L. Saltmarsh,

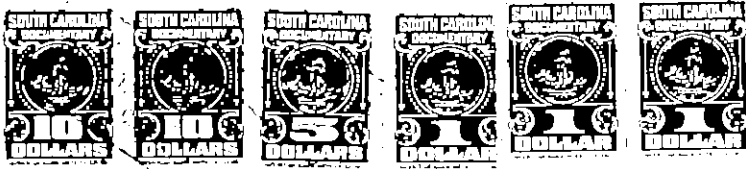
in consideration of Thirteen Thousand, Nine Hundred Fifty and No/100-----Dollars,
