All my right, title and interest, the same being an undivided one-half (1/2) interest, in and to the following:

ALL that certain piece, parcel and tract of land on the Northwest side of Grove Road in the County of Greenville, State of South Carolina, being shown and designated as Tract 3 and a small portion of Tract 2 on plat of the property of the E. H. Kern Estate, made by W. J. Riddle, Surveyor, in August, 1945, and recorded in the Greenville County R.M.C. Office in Plat Book O, at Page 199, and having, according to said plat, the following description:

BEGINNING at an iron pin in the center of Grove Road joint front corner of Tracts 3 and 4, and running thence with the line of Tract 4 N 68-0 W 1180 feet; thence N 20-0 W 100 feet to an iron pin and stake; thence N 73-0 E 140 feet to an iron pin, joint rear corner of Tracts 3 and 2; thence S 70-45 E 687.8 feet to a point; thence N 80-09 E 85.8 feet to a point; thence S 68-14 E 388.5 feet to a point in the center of Grove Road; thence with the center of Grove Road S 27-40 W 200 feet to the point and place of beginning.

This being the same property conveyed to Ruth Kern Watson by deed recorded in the Greenville County R.M.C. Office in Deed Book 294, at Page 4 and deed to James Harry Watson and Ruth Kern Watson recorded in the Greenville County R.M.C. Office in Deed Book 582, at Page 528. Both the said James Harry Watson and Ruth Kern Watson having died and the grantor and the grantee herein are the sole heirs at law, reference being made to the appropriate records in the Greenville County Probate Court.
