KNOW ALL MEN BY THESE PRESENTS, that I, PEARL C. ATWOOD,

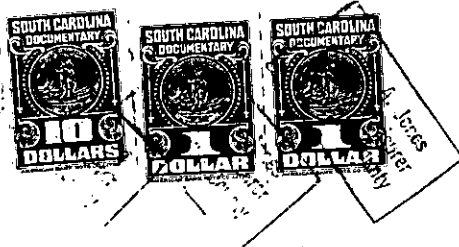
in consideration of SIX THOUSAND (\$6,000.00) \* \* Dollars,
