the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release JOHN T. DOUGLAS, JR ASTRUSTEE, upon the terms and conditions herein set forth:

ALL our right, title and one-third interest in and to all that piece, parcel or lot of land together with buildings and improvements fronting 121.5 feet on the Southern side of the Buncombe Road at the intersection thereof with the Cedar Lane Road near the City of Greenville, in Greenville County, South Carolina, and having 100 feet on the Eastern side of Huff Street formerly known as Pike Road, said property being located near the intersection of Buncombe Road with the right of way of the Piedmont & Northern Railway Co. and shown on the Greenville County Block Book as Lot 1, Block 7, on Sheet 149.

The above described property is a portion of the same conveyed to Ida J. Dacus by deed of Annie D. Gaines recorded in the RMC Office for Greenville County, S. Douglas, Jr., David D. Douglas and Anne Douglas Hart, as beneficiaries of this trust, the trustee herein named to be specifically empowered from time to time to convey the whole or any part of the above described property to any purchaser or purchasers by fee simple warranty deed or deeds. No purchaser shall be bound to look into the authority of the aforenamed trustee to convey said property, in whole or in part, or be liable to see to the application of the proceeds of sale of the same.
