ALL that piece; parcel or lot of land situate, lying and being on the Northwestern side of Jamestown Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 8 as shown on a plat of Pelham Estates, prepared by C.
