pipe line or lines described as new thirty-six (36") inch main in, upon and through the property of Nora N. Roe, Robert B. Roe, James A. Roe, and Boyce T. Roe, as shown on a plat prepared by Greenville Water Works in October, 1971, a copy of said plat is attached to and made a part of the Notice of Condemnation.

The location of the said right of way and pipe line or lines as the same pass through and effect the property of Nora N. Roe, Robert B. Roe, James A. Roe, and Boyce T. Roe, will enter the northern boundary line of the property of said landowners at station 20+30 of the survey of the Contract number 42 new pipe line right of way, and then runs through the property of the said landowners in a generally southerly direction to a point on the north side of the right of way of U. S. Highway 25, being a distance of approximately two hundred and forth-five (245') feet in length.

The property affected by this right of way is the same property conveyed to Nora N. Roe, Robert B. Roe, James A. Roe, and Boyce T. Roe by deed of B. Frank Thackston, as Trustee under the Will of Helen Roe Thackston, dated October 13, 1970, recorded in the Greenville County R.M.C. Office in Deed Book 900, at Page 350. Reference is also made to deed recorded in the Greenville County R.M.C. Office in Deed Book 860, at Page 113.

and to construct and maintain in, upon and through said premises, in a proper manner, a pipe line or lines, air vents, blow off connections, manholes and other necessary apparatus incident thereof, using the necessary appliances and machinery for such work for the purpose of conveying water through the premises above described, together with the right at all times to enter upon said premises for the purpose of inspecting said line or lines and making necessary repairs and alterations thereon, together with the right to cut away and keep clear of said pipe line or lines all trees and other obstructions that may in any way endanger or interfere with the proper operation of or access to the same.

It is understood and agreed that the right of way to be used under this contract is to be thirty (30') feet in width (and lies on the Eastern side and is contiguous to and runs along the fifty (50') foot right of way described in Deed Book 393, Page 85) throughout the entire length which is approximately two hundred forty-five (245') feet more or less, and the damage, which THE CITY OF GREENVILLE, SOUTH CAROLINA, is to be liable for during construction, is to be confined to this strip and nothing beyond. The location of the pipe line or lines, when laid, will determine the definite location of the right of way. The center of the pipe line or lines shall be accepted as lying five (5') feet to eleven (11') feet from the western boundary line of this right of way. The remaining twenty-five (25') feet of said right of way shall lie east of the center of said pipe line or lines and the entire right of way may be used for the purpose of installing the pipe line or The location of said pipe line or lines is to be approximately along the line as now located and staked out by the engineers, subject to a variation of not exceeding five (5') feet either way and no obstruction shall hereafter be placed on said thirty (30') foot right of way.
