in consideration of the sum of Ten Thousand Six Hundred and No/100 (\$10,600.00)----- DOLLARS,

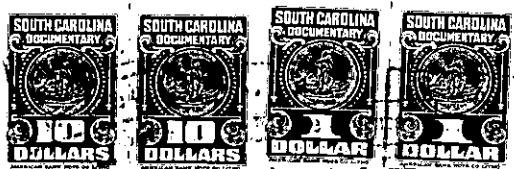
