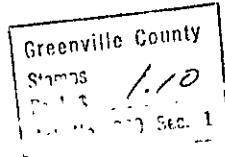
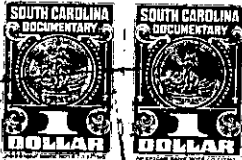
KNOW ALL MEN BY THESE PRESENTS, that James R. Mann, Jr.
