All that certain piece, parcel or lot of land situate, lying and being at the Northwestern intersection of Turpin Drive and Davis Avenue near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 10 as shown on plat entitled "Trammell Heights", dated August, 1953, prepared by J. Mac Richardson, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book EE at page 28, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin at the Northwestern corner of the intersection of Turpin Drive and Davis Avenue and running thence with the Northern side of Turpin Drive N. 48-56 W. 203.6 feet to an iron pin on the Northern side of Turpin/ at the joint corner of Lots Nos. 10 and 12; thence with the line of Lot No. 12 N. 23-54 E. 90 feet to an iron pin in the line of Lot No. 12 at the joint rear corner of Lots Nos. 10 and 11; thence with the line of Lot No. 11 S. 54-23 E. 192.8 feet to an iron pin on the Western side of Davis Avenue; thence with the Western side of Davis Avenue S. 20-19 W. 110 feet to the point of beginning.
