unto B. Frank Mayfield, his heirs and assigns forever:

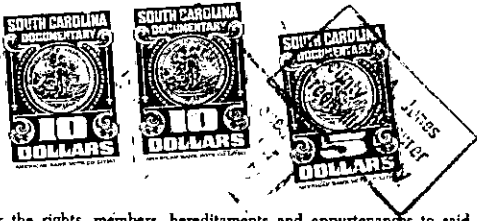
