to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

CHALMER N. GREENE and MARCELLE V. GREENE, their heirs and assigns forever, all of my right, title and interest in the below described real estate, being an un-divided one half interest.

All that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, about five miles North of Greer, S. C., lying East from State Highway No. 14, and West and South of two county roads, and being a part of the same conveyed by W. P. Gibson Feb. 6th. 1907, recorded in deed book TTT page 564, Greenville County R. M. C. Office and having the following courses and distances, to wit:

Beginning at an old iron pin on the line of Redge Ponder Estate, joint corner of Lot No. 1 as shown plat of the other property now or formerly of Tessie, made by H. S. Brookman, surveyor, dated February 25th. 1952, and runs thence with Ponder line, N. 45-23 E., 414 feet to a nail or cap in the center of county surfaced road (iron pin set back on line 23 feet); thence with the said county road N. 24-37 W., 542.5 feet to nail and cap in center of the cross roads; thence with the second road, S. 67-23 W., 537.5 feet to an iron pin on the south edge of the said road, joint corner of Hoyt Tapp's lot and lot No. 3 as shown on the above mentioned plat; thence with the rear line of lot Nos. 1, 2 and 3 on said plat, S. 36-30 E., 720 feet to the beginning corner and containing 6.73 acres more or less.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

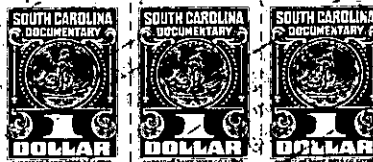
