An undivided one-half interest in and to the following described real estate:

ALL that certain piece, parcel and tract of land on the Northwest side of Grove Road in the County of Greenville, State of South Carolina, being shown and designated as Tract 3 and a small portion of Tract 2 on plat of the property of the E. H. Kern Estate, made by W. J. Riddle, Surveyor, in August, 1945, and recorded in the Greenville County R.M.C. Office in Plat Book O, at Page 199, and having, according to said plat, the following description:

BEGINNING an an iron pin in the center of Grove Road joint front corner of Tracts 3 and 4, and running thence with the line of Tract 4 N 68-0 W 1180 feet; thence N 20-0 W 100 feet to an iron pin and stake; thence N 73-0 E 140 feet to an iron pin, joint rear corner of Tracts 3 and 2; thence S 70-45 E 687.8 feet to a point; thence N 80-09 E 85.8 feet to a point; thence S 68-14 E 388.5 feet to a point in the center of Grove Road; thence with the center of Grove Road S 27-40 W 200 feet to the point and place of beginning.
