Dollars the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Louise B. Wykes, an undivided fifteen per cent interest in the whole and to Bernice B. Compton an undivided fifteen per cent interest in the whole in and to the land hereinafter described excepting one acre which is excluded from this conveyance.

All that piece, parcel or lot of land partly within and partly without the corporate limits of the City of Greenville being situate on the north side of the Pelham Road and being shown on plat of C. C. Jones, Engineer, dated February 8, 1952 containing 10 acres more or less and having the following metes and bounds:

BEGINNING at an iron pin on the north side of Pehlam Road at the southeast corner of tract conveyed by us to Yorktown of Greenville Limited Partnership by deed recorded in Deed Book 752 at Page 361 in the R.M.C. There is excepted from this conveyance one acre of land lying in the south-west corner of the above described tract which one acre of land will front 210 feet on the Pelham Road with a depth in parallel lines of 210 feet, the west line of this one acre being the east line of the Yorktown property which runs N. 24-38 E. and being the first course or call in the above ten acre tract.
