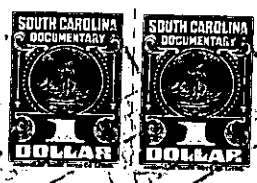
in consideration of Seven hundred dollars (\$700.00) and assumption of mortgage set Dollars,
