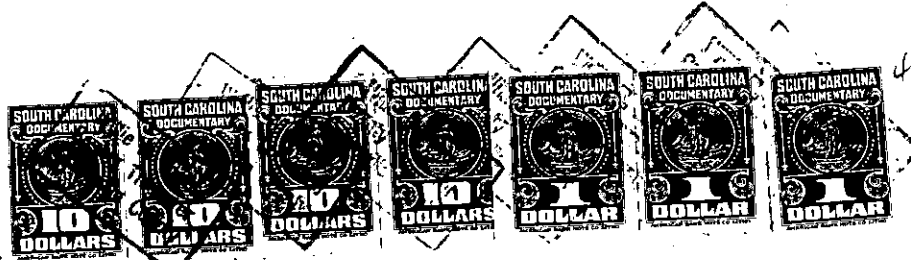
KNOW ALL MEN BY THESE PRESENTS, that

WILLIE L. PASLEY AND ETHEL H. PASLEY, THEIR HEIRS AND ASSIGNS FOREVER:

ALL that piece, parcel or lot of land in the State of South Carolina, County of Greenville, lying and being on Panorama Court, known and designated as Lot No. 20 on a plat of Plantation Estates, made by Campbell and Clarkson, Surveyors, dated December 16, 1971, and recorded in the RMC Office for Greenville County in Plat Book 4-N, Page 48, and having, according to said plat, the following metes and bounds, to wit:
