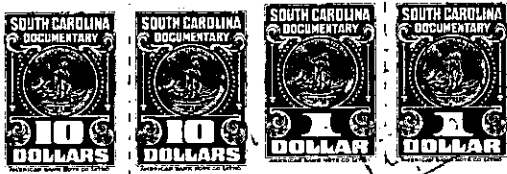
KNOW ALL MEN BY THESE PRESENTS, that Jack W. Lollis -----
