- 3. The property referred to by this agreement is described as follows: John T. Farmer, his heirs and assigns, all of my right, title and interest in the following described real estate, the same being an undivided 1/hh interest in said property: All of that certain lot of land with the buildings and improvements thereon in Ward 1 of the City of Greenville, in Greenville County, State of South Carolina, on the corner of Pinckney Street and Frank Street, and having the following metes andbounds, to-wit: Beginning at a stake corner of Pinckney Street and Frank Street and Frank Street and running thence with Pinckney Street, N. 3h W. 150 \$ feet to a stake; thence S. 56 W. 50 feet to a stake; thence S. 3h E. 150 \$ feet to a stake on Frank Street; thence N. 56 E. 50 feet along Frank Street to the beginning corner. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Eank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
