

Know All Men by These Presents:

That I, Fannie S. Forrester, in the State aforesaid, in consideration of the sum of Forty Thousand and No/100 (\$40,000.00)----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said The School District of Greenville County, its successors and assigns forever:

ALL that piece, parcel or tract of land, situate, lying and being in the Township of Butler, County of Greenville, State of South Carolina, and being known and designated as the "Fannie Forrester Tract" of the property of W.H. Smith and having, according to a plat prepared of said property by Madison H. Woodward, R.E.S.C., September, 1964, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book HHH, at Page 111, the following courses and distances, to-wit:

BEGINNING at a nail and cap in or near the center of Black's Road, joint corner of property of the Grantor herein and Boyce Smith, and running thence, N. 86-10 W. 144 feet to a point; thence, S. 57-0 W. 236 feet to an iron pin; thence, N. 0-54 W. 239 feet to a point; thence, N. 2-54 W. 204 feet to an iron pin; thence, N. 56-38 W. 422 feet to an iron pin; thence, N. 14-15 E. 309.4 feet to an iron pin; thence, N. 12-05 E. 117.5 feet to an iron pin; thence, S. 75-45 E. 635 feet to an iron pin; joint rear corner of property of the Grantor herein and Boyce Smith; thence with the joint line of said property, S. 2-20 W. 815 feet to a nail and cap in or near the center of Black's Road, the point of beginning.

This being the same property conveyed to the Grantor herein by deed dated October 22, 1964, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 766, at Page 284.

This property is conveyed subject to all easements, rights-of-way, conditions and restrictions of record.
