

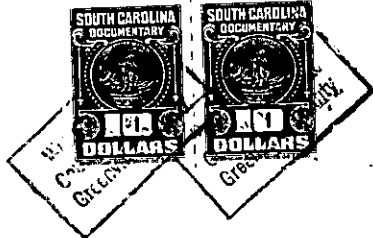

KNOW ALL MEN BY THESE PRESENTS That Trollingwood Realty Company,  
partnership formed  
a corporation organized under the laws of the State of South Carolina  
and having its principal place of business at Greenville  
in the State of South Carolina for and in consideration of the  
sum of Nine Thousand Nine Hundred (\$9,900.00) -----

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Robert E. Odom, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being at the northeastern terminus of Shadowmere Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 32 as shown on a plat of Trollingwood, Section 1, Revised, prepared by Enwright Associates and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 4-R at pages 12 and 13, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin at the northeastern terminus of Shadowmere Drive at the joint front corner of Lots Nos. 31 and 32 and running thence with the line of Lot No. 31 N. 10-44 W. 126.8 feet to an iron pin located at the normal pool line of a lake known as Lake Trollingwood; thence with the normal pool line of said lake the following courses and distances: N. 67-04 E. 158.1 feet to an iron pin, thence N. 88-02 E. 164.1 feet to an iron pin, thence S. 7-57 E. 107.6 feet to an iron pin at the joint rear corner of Lots Nos. 32 and 33; thence with the line of Lot No. 33 S. 63-05 W. 268.4 feet to an iron pin at the northeastern terminus of Shadowmere Drive; thence with the northeastern terminus of Shadowmere Drive N. 59-30 W. 71.4 feet to the point of beginning.

This is a portion of the property conveyed to the Grantor herein by deed of R. B. Landers, et al, dated December 10, 1970, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 906 at page 390.

This conveyance is subject to all restrictions, zoning ordinances, setback lines, roadways, easements and rights-of-way, if any, affecting the above described property, including restrictions applicable to Trollingwood, Sec. 1, recorded in the R.
