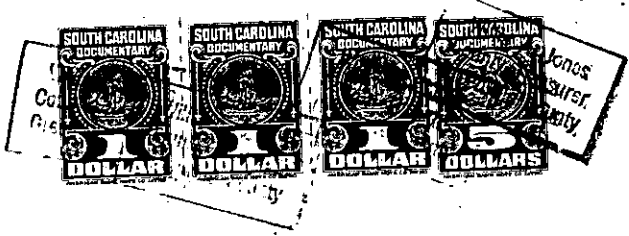
KNOW ALL MEN BY THESE PRESENTS, that Hubert Hunt and Bobbie Lee McCarroll Hunt
