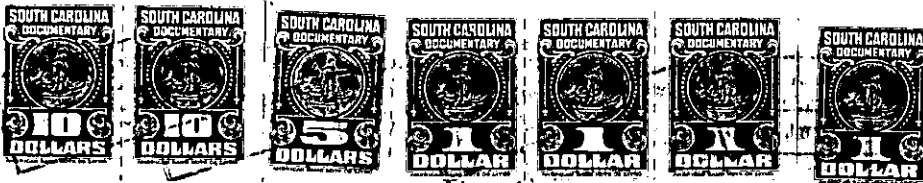
KNOW ALL MEN BY THESE PRESENTS, that Harold C. Baker,
