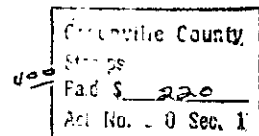

Dalton, December 1957, the following metes and bounds, courses and distances, to wit:

Beginning at an iron pin on the southern side of Rogers Avenue, which iron pin is 100 feet west from the southwest corner of Rogers Avenue and Assembly Drive, and 6 feet west from the joint front corner of Lots Nos. 15 and 16; thence S. 5-50 E. 150.5 feet to an iron pin in line of Lot No. 13; thence with the line of Lots Nos. 13 and 12, S. 83-55 W. 80 feet to an iron pin; thence N. 5-50 W. 150.5 feet to an iron pin on the south side of Rogers Avenue; thence with the south side of Rogers Avenue, N. 83-55 E. 80 feet to the beginning corner.
