KNOW ALL MEN BY THESE PRESENTS, that Elizabeth Riddle McC. Loftis, ---

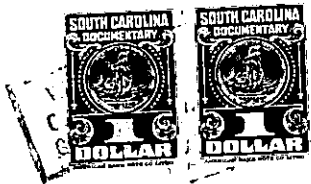
in consideration of -----Nine Hundred and No/100 (\$900.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto David G. Traxler, Sr., his heirs and assigns:

ALL those pieces, parcels or lots of land lying and being situate on the Southerly side of Carver Road in Chick Springs Township, Greenville County, South Carolina, being shown and designated as Lot 49 and the easterly and adjoining one-half of Lot 50 according to plat of property of Lily McC. Loftis, prepared by Terry T. Dill as revised through February 23, 1961, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "GGG" at Pages 456 and 457, and having, according to said plat the following metes and bounds, to-wit:
