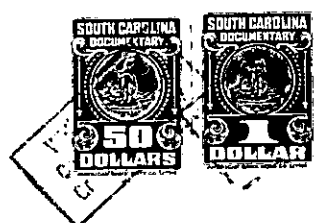
In consideration of Twenty-Five Thousand Five Hundred and NO/100-----(\$25,500.00)----- Dollars,
