Ar Bear REAL PROPERTY AGREEMENT

3. Hereby assign, transfer and set over to Bank, its successors and assigns, all monies now due and hereafter becoming due to the undersigned, as rental, or otherwise, and howsoever for or on account of that certain real property situated in the County of

Greenville , State of South Carolina, described as follows:

On that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina being known and designated as Lot #4 on the Laurens Road according to plat of property of the grantor which plat is reported in plat Book H at page 219 in the R. M. C. Office for Greenville County and being known as the W. W. Holcombe property and having such metes and bounds as shown thereon.

and hereby irrevocably authorize and direct all lessees, escrow holders and others to pay to Bank, all rent and all other monies whatsoever and whensoever becoming due to the undersigned, or any of them, and howsoever for or on account of said real property, and hereby irrevocably appoint Bank, as attorney in fact, with full power and authority; in the name of the undersigned, or in its own name, to endorse and negotiate checks, drafts and other instruments received in payment of, and to receive, receipt for and to enforce payment, by suit or otherwise, of all said rents and sums; but agrees that Bank shall have no obligation so to do, or to perform or discharge any obligation, duty or liability of the undersigned in connection therewith.

4. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebted-ness then remaining unpaid to Bank to be due and payable forthwith.

5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.

Upon payment of all indebtedness of the undersigned to Dank this agreement shall be and become void and of no effect, am until them it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inner to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Ban showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness ancontinuing force of this agreement and any person may and is hereby authorized to rely thereon.
