and assumption of mortgage set out below
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto

All that certain piece, parcel, or lot of land situate, lying and being in
the State of South Carolina, County of Greenville, being known and designated as
Lot No. 66 as shown on a plat of a subdivision of Abney Mills according to a plat
thereof recorded in the R. M. C. Office for Greenville County in Plat Book QQ
at Page 53, and having, according to said plat, the following metes and bounds,
to-wit:

BEGINNING at an iron pin on the southwestern side of Circle Road at the
joint front corner of Lots Nos. 65 and 66, which iron pin is located 582.2 feet from
the intersection of Circle Road and Renfrew Avenue, and running thence along the
joint line of Lots Nos. 65 and 66, S. 32-09 W. 129 feet to an iron pin, joint rear
corner of Lots Nos. 65 and 66; running thence along the rear line of Lot No. 66,
N. 72-09 W. 75 feet to an iron pin at the joint rear corner of Lots Nos. 66 and 67;
running thence with the joint line of said lots, N. 32-09 E. 147.9 feet to an iron pin
on the southeastern side of Circle Road, joint front corner of Lots Nos. 66 and 67;
